1. This Act may be cited as the *Corporate Affairs and Intellectual Property Office Act*. Short title.

"Assistant Registrar" means the Assistant Registrar of Corporate Affairs and Intellectual Property;

"Intellectual Property" has the meaning assigned to it by Article 2 of the *Convention Establishing the World Intellectual Property Organization* signed at Stockholm on July 14, 1967;

"Registrar" means the Registrar of Corporate Affairs and Intellectual Property.

3. (1) There is established by this Act the Corporate Affairs and Intellectual Property Office.

(2) The Registrar is responsible for the administration of the Corporate Affairs and Intellectual Property Office and shall be assisted by the Assistant Registrar and such other officers as are necessary for the purpose of carrying out the functions of the Registrar under this Act and under any other enactment vesting duties, authority and responsibility in the Registrar.

Functions of Registrar. 1991-1. 4. (1) The functions of the Registrar are those assigned to the Registrar under

(2) The Registrar and the Assistant Registrar shall have such rights and discharge such duties relating to the office of Notary Public as are necessary for the purpose of carrying out the functions referred to under subsection (1).
